What is the Forum being asked to decide?

- 1. The paper provides an update to the National Funding Formula (NFF) for 2020-21, the continued direction of travel for Suffolk schools and further information on the additional funding provided and any changes.
- 2. A new and improved (optional) mobility factor has been introduced for 2020-21, therefore forum will need to decide if this should be introduced to the Suffolk formula or to continue using the same factors as in 2019-20. Three proformas have been produced:
 - i. Using the same factors as 2019-20
 - ii. Introducing the mobility factor where £0.8m would be directed to those schools with a mobile pupil population.
 - iii. Transferring 0.5% to other DSG blocks

Reason for recommendation

3. The recommendation is to continue to follow the NFF to determine schools' budgets in 2020-21 and to agree the introduction of the mobility factor (further details in the main report and Model 2 in Annex B). This will be the third year Suffolk has followed the NFF.

Alternative options

4. There are no alternative options in respect of the NFF and Forum have agreed to follow the NFF. Forum could decide not to introduce the mobility factor in which case the same factors would be used in 2020-21 as in 2019-20.

Who will be affected by this decision?


5. The funding formula used to calculate school budgets for 2020-21 will affect all LA maintained schools, free schools and academies.

Main body of the Report

NFF Update

Table 1

- 6. Increases to funding announced in August 2019 will see the Dedicated Schools Grant (DSG) rising by £2.6 billion for 2020-21, £4.8 billion for 2021-22 and £7.1 billion for 2022-23 compared to 2019-20. The £2.6 billion includes the £780 million extra for high needs in 2020-21. On top of this £1.5 billion per year is being provided to fund additional pension costs for teachers.
- 7. Schools Forum agreed that Suffolk should adopt the NFF with effect from 2018-19 and this approach is continuing when setting the budget for 2020-21. This will ensure that the funding at school level remains consistent to reflect the funding which will be received by individual schools when the NFF is fully implemented. At this stage there is no set date when the 'hard' formula will be introduced. By agreeing to follow the rationale as set out by the ESFA it will enable a smooth transition to the 'hard' NFF and allow our schools to plan with more certainty in the lead up to it being implemented. There are now 81 LAs which have moved to the NFF in 2019-20.
- 8. The structure of the schools NFF in 2020-21 is not changing, although there have been some minor technical changes. **Table 1** below shows the 15 factors that comprise the formula.

Figure 1: This illustrates the factors that will be taken into account when calculating schools block DSG funding allocations through the national funding formula. It is not to scale. Funding for factors in italics will be allocated to local authorities on the basis of historic spend.

- 9. Feeding into the above table are the NFF unit values of funding. **Annex A** shows the unit values for each factor in the 2020-21 formula. The additional money has also resulted in the unit values increasing on those used in 2019-20.
- 10. The funding floor is set at 1.84% which is in line with the latest forecast GDP deflator (the measure given to general inflation). This means that every school in the country will attract an increase in their pupil led funding of at least 1.84% per pupil compared to the 2019-20 NFF allocations. However, if schools see reductions in pupil numbers, funding levels will be lower. Minimum Funding Guarantee (MFG) has been set between +0.5% and +1.84% which allows LAs to mirror the NFF growth.
- 11. The minimum per pupil funding levels (MPPF) have been increased as a result of the additional funding. These are:
 - £3,750 for primary schools
 - £5,000 for secondary schools
 - Primary schools MPPF will then rise to £4,000 in 2021-22.
- 12. MPPF means that every school receives the same per pupil levels of funding. Within Suffolk, based on current data, 35 schools would require an adjustment to ensure that they reach these per pupil funding levels. In cash terms based on the current information, £2.5m is needed from the formula to 'boost' these schools.
- 13. The number of schools on MPPF may increase in 2021-22 (after further investment of £2.2 billion) with the minimum value for primary schools rising to £4,000.
- 14. In total cash terms Suffolk sees a 5.24% increase in schools block funding, excluding the growth element (which was £3.24m in 2019-20). Total indicative funding equates to £427.3m. Per pupil, the increase is just over £200 on 2019-20. Including an estimate for growth based on 2019-20 allocations and deducting the amount the LA budgets for growing schools (£1.780m) the total to be allocated to schools at this point is £428.8m.
- 15. LAs will not find out their growth allocation until the final October 19 census figures are released by the EFSA in December 2019. Final allocations are therefore liable to change from what we know at this point.
- 16. See Table 2 below for DSG allocations for 2020-21.

17. As presented at the July meeting, growth funding is allocated within our schools' block NFF allocations. For 2019-20, growth funding has been allocated to LAs using a new formulaic method based on actual growth between the successive October censuses. The change in the method of funding LAs has not altered the way in which authorities can allocate funding locally. The amount calculated for Suffolk is £3.24m which is significantly higher than the current budget held of £1.78m. The £1.46m difference is currently included in the schools' block funding. With further growth in pupil numbers expected the growth calculation for Suffolk is likely to be higher in 2020-21.

Mobility

- 18. The mobility factor has not been used in Suffolk's formula for several years (it has always been an optional factor) due to the unreliable nature of the data. For 2020-21 the EFSA are introducing a formulaic approach to allocate funding on a more reliable basis.
- 19. The new methodology involves tracking individual pupils using their unique pupil reference number (UPN) through censuses from the past 3 years. If the pupils first census was spring (excluding reception pupils starting in January) or summer, they are classified as a mobile pupil. Pupils are not included that joined after the summer census or before the autumn census. This is because the first census these pupils are captured on is the October census.
- 20. The EFSA believes that this methodology offers a significant improvement on the local methodologies that were used. The mobility factor will then allocate funding to those schools that have mobile pupils in each phase above a 6% threshold. All mobile pupils above the threshold will be allocated a per pupil amount at a rate of:
 - £875 for primary
 - £1,250 for secondary
- 21. The rates have been set by the ESFA to broadly reflect the levels of mobility funding used by LAs allocating this factor in their formulas in 2019-20 and

increasing the funding in order to extend to all other LAs in 2020-21 and to use in their formula mirroring NFF.

- 22. As a result of the change in mobility, two proformas have been produced and shown in **Annex B.** Model 1 using 2019-20 factors. Model 2 introducing the mobility factor.
- 23. By adding in the mobility factor, it means (based on current data):
 - £0.829m allocated through this factor (approx. 0.19% of the total schools block funding).
 - 131 primary schools would see funding through mobility (£0.672m);
 - And 12 middle and secondary schools (£0.157m).
 - 51% of schools would be funded from this factor at an average of £5,797 per school.
 - Lowest amount being £30.94 and the highest £44,094.
 - The per pupil amount diverted into this factor is £8.92.
 - Schools attracting mobility funding will be able to support these pupils and manage costs incurred by high levels of pupil mobility.

Movements from the schools block

- 24. The schools block is ring-fenced in 2020-21, but LAs can transfer up to 0.5% of their schools' block into another block, with the approval of schools forum.
- 25. Based on model 3 **(Annex B)**, if the forum were to agree a 0.5% transfer to support the other DSG blocks of funding, £2.152m would be transferred out. This would reduce the total allocation to schools to approx. £426.6m. The per pupil reduction would work out at £23.18.

Figure 2: This shows the unit values, total funding and proportion of funding for each factor in the formula. Total funding is rounded to the nearest million. Proportion of core total funding is rounded to the nearest 0.1%. The core total funding and proportion of core total funding columns are calculated excluding floor funding, using 2019-20 authority proforma tool data and 2018/19 general annual grant data. We have excluded growth funding from this table as this funding will be calculated using October census data, so we will confirm growth spend in December.
